1. What Is Tramadol?

Tramadol (brand names: Ultram®, ConZip®, Ryzolt®) is a synthetic opioid analgesic approved by the U.S. Food & Drug Administration (FDA) for the treatment of moderate-to-severe pain. It works by:

Mechanism	Effect
